Bar Service Addendum

PRICING:

The Responsible Party agrees to pay the price listed below for standard bar service:

Bar service is \$600 for 3 hours with 1 Bartender. Additional hours can be added for \$100 each additional hour. If a second bartender is needed there will be an additional fee of \$40 per hour added to the bar.

Service includes:

- A. Full Catering Service includes set up and cleaning, glassware, ice, and cocktail napkins.
- B. Building Rental only includes set up and cleaning, plastic ware, ice and cocktail napkins. If glassware is preferred there is a \$150 charge.

Circumstances where a second bartender is needed are as follows:

- A. Cash bars with over 50 drinkers
- B. Sponsored bars serving beer and wine only without soft drinks for over 150 drinkers.
- C. Sponsored bars serving beer, wine, and soft drinks with over 100 guests.
- D. Sponsored bars serving beer, wine, liquor and soft drinks with over 50 guests.

Please choose one of the following options for your bar service:

- Option 1: Sponsored Bar
Responsible party brings in all Alcohol, Mixers & Soft Drinks.
\$1.00 will be charged for guests over 100 per the catering count per hour.
Responsible party to provide beer in bottles, otherwise poured beer will be \$1.00 per glass poured.
- Option 2: Cash Bar
The Woods on Ninth provides all Alcohol, Mixers and Soft Drinks.
The Responsible party can pay for all or some of the cost and/or The Woods on Ninth can charge guests per drink.

Champagne toasts available starting at \$150. Includes toast for up to 50 people, \$2.00 per additional person.

POLICIES:

The hours of the bar service are from _____ to _____.

The bar **will not** open early or stay open late, unless you have paid for additional hours.

Signs will be posted at the bar with the hours it will be open. Please inform your guests there will be no exceptions.

DEPOSIT:

To reserve the bar service a deposit of \$500 (which deposit is separate and in addition to any deposit paid under the Contract) in the form of a cashiers check, money order, debit card or credit card is required at the time this Addendum is executed. Personal checks will not be accepted. The deposit will be held for any damages incurred during the event due to alcohol consumption. If no damages occur the deposit will be returned. Credit card or debit card deposits will be run as an authorization 2-3 days before the day of the event. If no damages occur the credit card authorization will be dropped within 5 business days. **If alcohol is brought on the premises by The Responsible Party or by guests without prior arrangements and is not removed immediately, you will forfeit \$500 of your deposit.** Please make your guests aware of all policies so no problems arise.

SERVICE:

The Woods on Ninth will provide a Utah licensed bartender to serve alcohol. The building is available until 10pm (unless facility rental is extended), under state law, alcohol service must end one hour prior to closing. Bar service can either be "Cash" or

“Sponsored” according to The Responsible Party. Cash bars indicate that The Woods on Ninth will purchase all alcohol and charge your guests per drink. Sponsored bars* indicate that The Responsible Party will purchase and bring in all the alcohol. Liquor will be dispensed according to state law. Any guest not complying with state law, or who brings in their own alcohol will be asked to leave the property, and if alcohol is not immediately removed, The Responsible Party will forfeit \$500 of the bar service deposit.

STATE LAWS:

The Responsible Party agrees that no underage drinking may occur at the event whatsoever. The Responsible Party shall ensure that no one over consumes alcohol at the event. The Responsible Party shall not allow any consumption of alcohol to occur in any way that violates any Utah law, including any applicable local ordinances or other regulations. The Woods on Ninth reserves the right to suspend alcohol service to one person or to multiple people should we be unable to remain in compliance with the law. State law prohibits serving a person alcohol to the point of intoxication even if the person in question is not driving.

LIABILITY:

The Responsible Party will be liable to reimburse The Woods on Ninth for any damage to the premises by attendees and/or persons associated therewith. The Woods on Ninth assumes absolutely no liability for personal injury, death, theft or loss related at all to the provision of alcohol.

DISTURBANCES:

The Woods on Ninth reserves the right to close the bar at any time during the event for any reason and without warning. If the disturbance is such that The Woods on Ninth believes a warning to the Responsible Party may resolve the disturbance, The Woods on Ninth may issue such a warning for the purpose of ending the disturbance. Notwithstanding the foregoing, The Woods on Ninth is not required to provide any number of warnings before suspending bar service where a disturbance has resulted. Suspension of alcohol service results in a forfeiture of the alcohol service charge.

\$500 deposit on credit card will be processed 2-3 days prior to event

***Sponsored Bars: You may drop off your alcohol the day before your event, no later than 5:00pm.**
